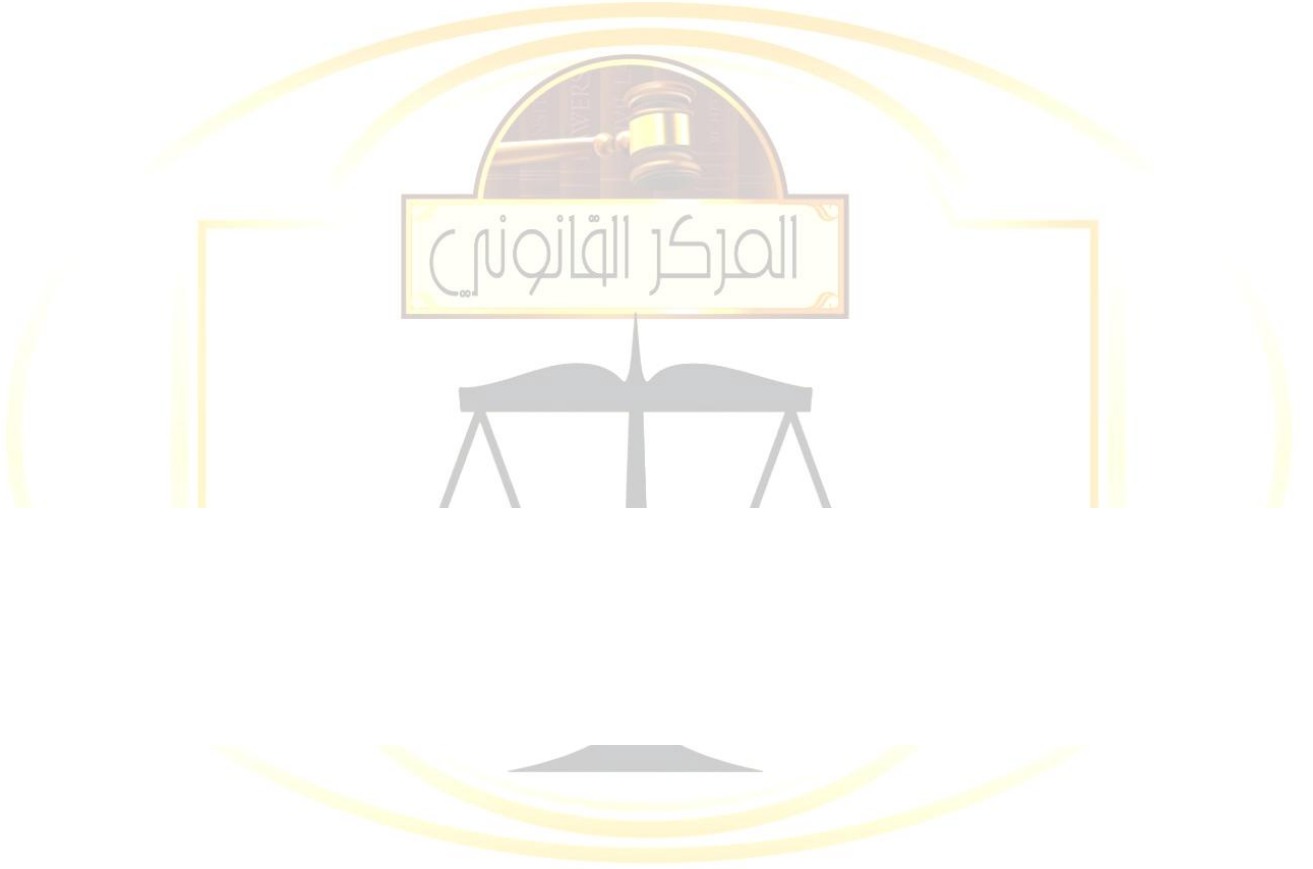

## **Summary:**

At the beginning of the military operation on Yemen in 26th of March 2015 which declared that they are targeting Huthies and the previous president Ali Saleh to restore the legality to the president Hadi because they revolted against him and who ran away to Al-Riad , this war it is not targeting them it is killing the civilians , and destroying proprieties also the civil institutions .

After three months of the starting of the military operation on Yemen they targeted Al-Hadirah village which is 8 KMs far away in the east south of the capital city – Sanhan district –Sana'a governorate – killed lots of civilians in this period without any legality and morality , this is a crime should be stop because it is a crime regarding to the international humanitarian law and all parties should involve in war and conflicts moreover, the houses are old and rural for innocent civilians of both children and women and aren't participate in fighting operations .

## **Description:**

At 1:30 P.M on Friday in the 1st of July 2015 , men and children finished their praying in the mosque of the village while they were walking to their houses , they heard the flying of Saudi aircrafts and then a huge bombing in the mountain which is empty and it is 5 KM far away from the village in the south side, they heard the huge explosion so they ran to their houses after that the aircrafts deliberate targeted the village of missiles on the simple and rural houses and killed lots of men , women and children , one of the house is for the civilian called Mujali Mujali Ahmed and the other Hussin Al-Gawzi which destroyed them completely and cause a humanitarian disaster.

*The bombing led to kill 11 civilians among them four children and four women also injured eight civilians among them three children and three women some of them in dangerous cases ,moreover completely destruction of two houses and kill their livestock*



The team visited the village and they interviewed the Survivor from the butchery and documented the witnesses of civilians and victims' relatives and also visited the injured in the hospital and confirm that the Saudi Arabia targeted an innocent civilians in a residential area which is a breach of the international humanitarian law.

### **Witness's statement:**

#### **Abdullah Hussein Al-Jawzi (35 Years Old)**

One of the survivor from the bombing , he is a bus driver , he has a simple house in construction it is just one floor , he has eight members (his wife, children ,his mother , his brothers) the house is what they inherited from his poor father ,he described the details of the Saudi aircrafts bombing and killed four of his family and injured him, his sister ,nephews , he reported that " after we went out from the mosque it was one and a half o'clock ,me and my neighbor Mojali went to our houses , he entered to his house and I talked to some of my friends in front of my house we heard the flying of Saudi aircrafts and then a huge explosion on a mountain which is 5 KMs far away from the village then the aircrafts bombed my house and my neighbor Mojali's house by missile I injured in my head, face and hands my house and my neighbor house turned to debris my wife Wafa and Najm who is a newborn died while she was feeding him , my dearest mother (80 years old)also died ,my sister Mona (35 years old) , my nephews Taha and Ahmed died because they were in my house , me and my sisters Hanan and Han'a , I lost my family house ,and the bus which is the my livelihood also the livestock , I don't know what is my guilty to bomb my house and destroy my life.

#### **The child Akram Mojali Mojali (17 years old) and his sister Fatima (13 years old)**

Who survivor from the bombing and from the family which contains of eight members ,Akram reported while he was crying " after we return from the mosque



on Friday , my father was taking rest in our house from the heat of the sun also he was fast, my mother was neating our house, my brothers Eman, Mojali , Ziad and Mohammed were playing in the hall of the house , my sister Fatima was with my mother in the kitchen , the Saudi aircrafts bombed our house and our neighbor house Abdullah and destroyed on our heads , they took us from under debris I was unconscious they took us to the hospital , all my family died except me and my sister Fatima .

**Fatima:**

Reported " after praying on Friday , the Saudi aircrafts bombed our house by missile and killed my father, mother , and sisters , also I injured and my brother Akram by dangerous injuries , moreover our house totally destroyed , we don't have place to stay in it and we don't have anything also our clothes , we don't know where to go , we are orphans.

**Hanan Hussien Al-Jawzi (20 years old) and his sister (30 years old)**

we interviewed their and they wounded she reported " the missile bombed our house when I was in the bath and the roof of the bath fall on my head ,I injured in my right leg, back ,and my head they took me from under the debris to the hospital in 48 ST. my house completely destroyed, I surprised that my mother ,sister ,my brother's wife and her newborn child Najm who is ten days old died , as you see I am in my uncle's house<sup>1</sup>, because I don't have place to live in , I lost my family and my house.

**Hana'a:**

Reported " the missile fall down on our house I was in the kitchen which is outside of the house in the garden while I was preparing food for my sick mother I found myself lying on the ground because of the explosion I injured in my head and arm

my mother, sister and brother's wife and his son died also injured our nephew Taha and Tarq, moreover our house and our neighbor completely destroyed ,we don't know what we did to bomb our house.

**Jamil Mohammed Musleh (25 Years old)<sup>2</sup>**

Reported that "At 1:00 o'clock we heard the first missile on Al-Qarwan mountain which is 5 KMs and the second missile in Al-Hadeirah village which targeted of two citizen's houses ( Mujali Ahmed Mujali and Hussin Al-Jawzi ) destroyed them completely , killed all of them except girl and boy , injured seven others we took died from under debris (the wife of Abdullah Al-Jawzi her name is Afaf and her newborn baby he is ten days his name is Najm ) we took all the injuries to the hospital –Al-Jadi medical center- and buried all the killed citizens , moreover the bus destroyed which is the only livelihood of the family of Abdullah Hussin Al-Jawzi also damaged 15 houses inside of the village from the huge explosion .

**Ahmed Saleh Hassan Al-Jawzi ( 60 years old)<sup>3</sup>**

One of the relative victim reported that" I was on the roof of my house I saw the missile on the air was moving toward Al-Hadirah village it was fall down on my brother in law's house , I went to the location I saw the two houses were completely destroyed , we took the died from under debris (my niece Mona Hussin and the wife of Abdullah Hussin and her newborn baby who is ten days (Najm) also we took Latif Saleh Al-Jawzi and my nephew Taha Ahmed Hussin who is in dangerous case and he is in the hospital now) .

Lots of witnesses we met them they declared that there is no military camp inside and nearby it , all inhabitants are all citizens and most of them children and women.

Violation description according the general international law and international humanitarian law also the center recommendations.

- ➡  *The Legal Center* confirm that Saudi led - coalition breach the rules of the international humanitarian law also committed crimes against the innocent civilians rights which should accountability according to the international rules .
- ➡ The Saudi led coalition didn't comment about the accident in local and international media which confirm the overstepping of the international humanitarian law and committed crimes against the innocent civilians and aren't armed



*The Legal Center* call on international human rights organization to carry the humanitarian responsibilities and send investigation committees to investigate in violation , also appeal the international criminal court to speed investigate in these crimes and offer the committers to justice to protect the civilians, women ,children and civil locations.



*The Legal Center* call on countries and organizations to stop the war and targeting civilians and relief the civilians who displace from their houses and Compensation them as soon as possible.
