Abstract:

Direct bombing and targeting of displaced people IDPs is an extension of the series of crimes committed by the Saudi Arabian Air Force since the beginning of the war on Yemen. The crime of targeting a bus carrying displaced persons in the public road between Zabid Directorate and Al-Jarahi was not the first crime. IDPs are targeted whether they are in the camps designated for their shelter or on roads in the Yemeni provinces, which the aggression considers legitimate targets for its brutal crimes, which aims to terrorize the Yemeni people and kill more of them.

Event details:

Incident Details

In the early hours of Tuesday, June 26, 2018 more than 20 civilians were displaced from the city of Hodeida for fear of raids by the Alliance of Aggression, which forced them to leave their homes in the city of Hodeida, followed by direct and deliberate bombing. On Tuesday afternoon, a brutal raid targeted them in the public line between The Directorate of Zabid and the Directorate of Al-Jarahi near Mana's checkpoint, killing (9) and injuring (12) others, including children and women before their arrival to their villages to announce to all that the aviation aggression does not exclude anyone and its declared and hidden objectives are the killing of the largest number of civilians and terrorize the Yemeni people to achieve

what the Major Forces of Domination. For achieving that, it commits hundreds of crimes against humanity.

victims and witnesses' Testimonies:

A relative of the victims, named, Abdo Mohammed Zeid Tari, 38, tells us some details of the crime saying:

" I was Al-Jarahi Directorate, on Tuesday morning, when my relatives from Hodeida called me and told me that they were displaced from the city and were coming to stay at our house. The hours passed while we are waiting, but I was surprised when someone called me from the hospital and told me that the raids hit them in the public road before they arrived. I went to the hospital and found my three relatives dead. We took their charred remains and buried them. He told us the names of his relatives. He said, "Why does the air force target the displaced people and kill them?" "Where are the slogans used by the coalition of aggression and where is the human rights?"

'Abdalnour Hassan Majzaji, 25, who took the wounded with his children and his wife, said:

" We left the town of Hodeida for fear of air raids. My children, my wife and I were on a bus carrying more than 18 displaced people, all of them heading toward Al-Jarahi Directorate. When we arrived in the area of Maata, we were targeted on the public road. There was a civilian riding his motorbike and another after his donkey carrying foodstuffs near our bus. The missile killed more than 9 displaced persons and the one who was next to the bus. It was 11:00 in the morning, we miraculously got out the bus while the fire was all healed. My three children and my wife were seriously injured. They are now in intensive care. The bus driver, other passengers, the motorbike rider and the owner of the donkey alongside with his donkey were all killed. There is no justification for bombing us. We are IDPs from the city of Hodeida and heading to the hospital. The bus is civilian. It was not an armored vehicle or a military kit. He asked where

human rights and where the organizations are and how effective international laws and conventions criminalize targeting IDPs.”

Abdullah Mohammed Ali Wadih, 25, said:

" I transferred six wounded victims of the raid on the bus to Shazli Hospital, on Tuesday afternoon. After the raid took place, we rushed to the main road near Al-Jarahi checkpoint. The bus was burning and the wounded were screaming, including children and women, all of them displaced from the city of Hodeida heading Al-Jarahi Directorate. There were two of the victims; one of whom was heading to his modest grocery and other was a motorbike rider.

The driver of the bus named, Naseem Salem burned his body until he was roasted and no one was able to save him. There are others who have been in the bus with more than 9 dead and 11 injured, including children and women. There is no justification for this crime against the displaced."

Official Statements:

The security official in the Directorate said:

At 11:45 am on Tuesday, the Coalition of Aggression carried out a crime after forcing civilians to flee the city of Hodeida and then brutally tracking them and targeting them on the main road, killing and injuring more than 22 displaced persons in a crime added to a series of crimes that the war that aggression has been perpetrating.

Sheikh, Ibrahim Eidros, one of the elders of the region, said:

The Saudi aircraft launched a raid targeting a bus carrying displaced people as they passed through the main road to Al-Jarahi Directorate. More than 22 displaced persons, including children and women, were killed and wounded

Description of the violation according to the international humanitarian law:
