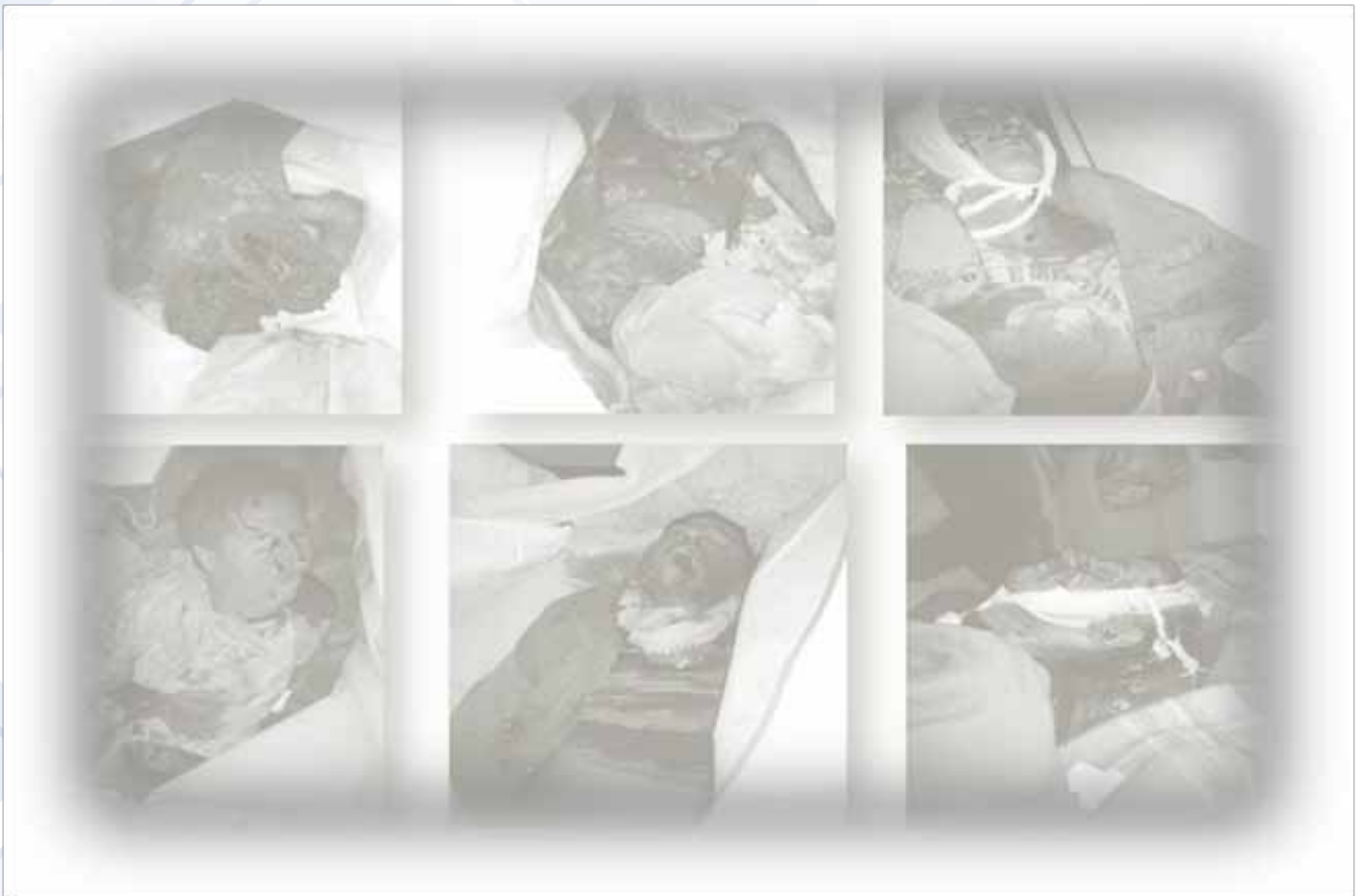

# Al-Karn Massacre Dhamar May 6, 2015



### **Violation place:**

**A residential area in the southern part of Dhamar province called (Dhamar Al Karn) 100 Km far from the southern part of the Capital city of Sana'a.**

### **Violation time and date:**

**8:15 am on Wednesday May 6th, 2015**

### **Violation type:**

**Airstrikes bombing houses on the head of their inhabitants caused the death of many civilians and the complete destruction of many civilian properties.**

### **Violators:**

**Saudi-led Coalition (Saudi Arabia, UAE, Kuwait, Qatar, Bahrain, Egypt, Sudan, Jordan, America).**

### **Description of the violation:**

**On Wednesday May 6th, 2015 people in Dhamar woke up by Saudi-led Coalition airstrikes' sound. Different places in Dhamar province were targeted according to eyewitnesses' statements. The airstrikes also, bombed a residential area in Dhamar province called Al karn causing the death of many civilians and damage on some houses. In addition, airstrikes bombed a highway that connects Sanaa and Taiz province, which caused the death of many people plus damage on civilian cars. As well as, a brick factory was completely damaged.**

### **Legal Center documented death, injuries, and damage cases according to witnesses' statements, medical reports, images, and videos.**

**Witnesses testified that « on Wednesday at 8:15 people heard the sound of several explosions nearby their neighborhood , immediately they went to the scene to provide aid, unfortunately, they found a huge damage on the brick factory caused the death of his owner, also, they found many dead bodies lying on the street and some injuries. In addition, some bodies were unidentified due to the horrible explosion".**

**Medical report:**

Director of Health Office in Dhamar province Dr. Mohammed Al Jumahi reported that the death toll has risen to 10 among them two children and one women and more than 23 injuries were distributed in different hospitals in the city, he also said the « hospitals in Dhamar are facing a serious shortage due to Saudi war.

**Damage:**

Saudi-led coalition airstrikes caused the complete destruction of 6 houses and the brick factory, 11 houses were partly destroyed plus a huge truck and a motorbike.

**List of some civilian properties were damaged , in some cases completely destroyed , in Saudi-led coalition airstrikes on Al Karn ,Dhamar province**

NO	Name	Violation
1.	Ali Hussein al-Haj	Causing minor injuries to some of his family members and the destruction of his house windows
2.	Ali Qaid Al-Mureydi	Causing injuries to one of his family members and destroying his three houses windows
3.	Mussad Ahmed Al-Qarni	Breaking the car glass and destroying the car roof
4.	Hakema Mohammed Naser Yahiya	Shattering her house windows
5.	Atiq Yahiya Ahmed Abdullah Al-Yemeni	Cracking some walls and destroying windows and damaging the house roof
6.	Mohammed Mohammed Ayedh Al-Jadbi	Destroying the windows and doors of his house, causing partial damage to the guard room, and causing damage to trees (Qat)
7.	Abdullah Al-Zerari	Causing minor injuries to some of his family members and cracking some walls of his two story house and destroying his house doors and car glass
8.	Abdullah Ali Yahiya Al-Dahabi	Causing destruction to four of his house doors
9.	Mohamed Saad Al-Hadda	Causing complete destruction to his house as well as his car , and severely wounding his family members .
10.	Ahmed Ahmed Ali Mussad	Causing partial destruction to his two story house
11.	Ali Al- Hubaishi	Causing complete destruction to his Brick Factory, Killing workers, Destroying the workers' rooms, Destroying a tipper 19/3045, and Causing partial destruction to his house
12.	Azih Mohammed Saleh Al-Rahmi	Causing partial destruction to the hall and damaging her two story house walls
