Abstract:

The Saudi Arabian warplanes committed a crime against Mujahid Muhammad Jassar family by four air raids resulting in the killing of children and women and injuring the father of the family and two of his grandchildren at 6:00 pm on Saturday, 2/12/2017.

Incident Details:

Mujahid Jassar and the families members of his sons, Nasser and Abdelalem, live in three houses that were targeted by the Saudi Arabian Aggressive warplanes by four air raids at 6 pm on Saturday while children and women were in the houses.

The Saudi Arabian warplanes launched two air raids targeted the house of / Nasser Mujahid Jassar and a raid targeted his father's house next to his and the fourth raid targeted the home of Abdelalem.

The first two raids resulted in the killing of all members of Nasser Mujahid's family. The mother and her four orphan children were killed. Their father was killed a year ago by the bombing to the Saudi Arabian warplanes.

The third attack targeted the neighboring house where the father of the family lives. Taki was killed, while his wife, children and sisters were wounded and the house was destroyed.

The fourth raid targeted the home of Abdelalem, killing his children, wounding three members of the family, killing sheep and destroying cars.



victims and witnesses' Testimonies:

The Witness and victim / Abdelalem Jassar told us the details of the incident saying:

"It was time after Almgheb (the time after the sunset), and I was outside the house on the farm. My children and wife were at home. My parents, brothers and nephews were inside our houses. I heard the warplanes launching of four rockets on our three houses where my parents, wife, brothers Taki and Nasser live. My house was destroyed, my wife, two children, two brothers (Taki and Nasser), and Nasser's sons were killed. The total number of casualties is 14 killed victims and 3 injured, most of them children and women, who have no fault and there is no reason to bomb our houses. We are civilians farmers".

The witness added " in the next day , the warplanes re –attacked targeted our pre-targeted houses by a raid, destroying everything including our cars and killing 40 sheep of sheep".

Witness / Majed Mujahid Mohammed Jassar, a member of the family, said:

"I was outside the house and we were surprised by warplanes flying. Four raids targeted our homes and destroyed my father's house and my brothers' two houses. My brother, Nasser was killed a year ago by a Saudi attack while his family members were killed in these attacks,(his wife and four children), and the houses were destroyed. The third raid targeted the house of my father next door, killed my brother Taki and his wife and two children and wounded my father and two child girls. The bombing resulted in the killing of 14 people, mostly children and wounding three others. The fourth attack destroyed the house of my brother Abdelalem over the head its residents and killed two children of my brother and his wife , while My father was seriously injured and everything was damaged inside the targeted houses, even the sheep killed.

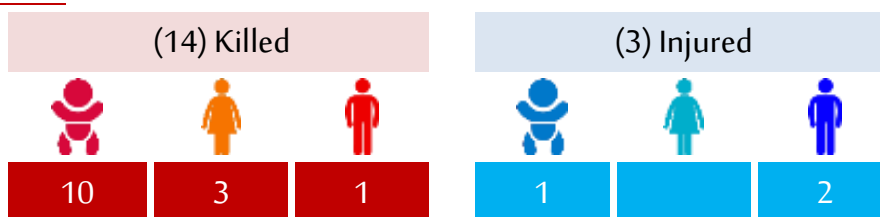
Three cars were burned. We no longer have anything due to the aggression. I do not know why it is justified to bombe civilian houses and kill children and women?".

Witness / Faisal Jassar Mohammed Jassar, told us

"During the bombing, I was a distance of the houses, I heard the explosion of the raids immediately after the bombing. The raids destroyed three houses belonging to my uncle Mujahid and his sons Abdelalem and Nasser, including children and women. The bombing resulted in the annihilation of Nasser Mujahid and Takis' family members including Taki. The situation was very bad. The children were under the rubble. 14 children and a woman were killed and injured my uncle and two children from the family . All the victims of the family of my uncle and two sons were killed. The attacks damaged everything even the sheep were killed and the three cars were destroyed. There is no reason to justify the bombing of civilian houses and the killing of children and women, the bombing was directly targeted houses for no guilt.

Description of the violation according to the international humanitarian law:

Legal center has revised the incident and made a full field scan on the targeted area specially the bombed houses and we found that the area and the houses are civilian objects have no presence of a military target. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- ▶ Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- ▶ Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- ▶ And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
