## Incident Details

As usual, the Saudi-led coalition has been continuing targeting civilians and civil objects without any consideration or respecting for the human rights or humanitarian law that criminalizes the targeting of civilians. Yesterday, the Saudi-led coalition warplanes launched an airstrike on Al-Khoba Port targeting a store of fish Resources belongs to the general Authority of Fish Resources , this store also used as a place of sleeping for the fishers . The attack resulted in the killing of three innocent people and the injuring of three others in addition to the destruction of the fish store and eight shops close to it. Legal Center for Rights and Development contacted with some witnesses in the targeted area, who in turn told us some information about the crime.

## victims and witnesses' Testimonies:

### **The witness /Mohammed Ahmed Ali Haza'a,40 years old, said**

" the Saudi warplanes launched an airstrike, at 8 pm on Monday, on a store of fish Resources belongs to the general Resources. The attack killed three civilians, injured four others, destroyed the fish store and damaged eight shops partially and completely".

### **The witness and victim / Mosa Ibraheem Ali Hanash,35 years old, and the uncle of the killed victim Adnan, told us saying:**

"my nephew Adnan and his cousin went to Al-Khoba port on a motorcycle before the attacking. At 8:15 pm the Saudi warplanes targeted Al-Khoba port, I got panicked since I know that my nephew is there, I immediately went toward Al-Khoba port to make sure about him and his cousin. When I reached there ,



the situation was so terrible, I saw the motorcycle got completely destroyed, I was shouting but Adnan did not reply, he had then been killed with his cousin by the Saudi warplane attacking".




**The Security officer in the targeted area / Saleh Hussein Al-Qahm,40 years old, reported us saying:**

" the raid targeted the store of fish Resources that belongs to the general Resources deliberately, killing 3 innocent people and injuring 3 others in addition to the destruction of the fish store and eight shops next to it.

## **Description of the violation according to the international humanitarian law:**

It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

## **Center Recommendations:**

- ▶  Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- ▶  calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- ▶  And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
