### **Abstract:**

Yemen and its innocent civilian population, particularly the people of the coastal province of Hodaydah, stile suffering the impacts of the war of Saudi coalition on Yemen. Many massacres are being committed throughout Yemen by the coalition warplanes. For more than 1062 days of war, thousands civilians have been killed and injured, dozens of families were displaced and have no source of food. These crimes and suffering are committed against Yemenis while the international community stile take no step to stop this disaster. Many epidemics and diseases brook out among people due to the kinds of the weapons that the Saudi-led are using in this war. The suffering of the civilian population has been further exacerbated, according to human rights reports issued by aid organizations and the United Nations including legal center. One of these brutal crimes committed by Saudi Arabian warplanes and its coalition at 9:00 am on Saturday, 10 February 2018. The attack resulted in the killing of 9 civilians, including 3 women and 4 children from the family of Ahmed Mohammed Naharee, the owner of the targeted house, and the injury of 2 civilians, one of them a child. The attack also destroyed the house completely.

### **Incident Details**

At 9:00 pm on Saturday, 10 February 2018, one or more warplanes of the Saudi Aggression Coalition launched two air raids targeting a civilian house contains of two families belonging to Ahmed Muhammad Naharee. the is located in Al-Sharja district, about 25 Kms from the



capital of Al-Hodaydah. The two barbaric airstrikes resulted in the annihilation of the entire Mohammed Ahmed's family. The family consists

of consisting of a father of 50 years old and wife of 45 years old and four children. The two girls were killed as they were sleeping. The raids assassinated their dream of living with their parents. Their bodies were scattered and torn into small pieces in a criminal scene that have not been seen only in the old time of the second world war. This brutality is now being repeated by Saudi Arabia and its alliance against Yemen without respecting to humanitarian law and its fundamental principles and the ethics of nations and peoples.

The two brutal raids also killed many civilians from another family living with the first targeted family and injured two others.

According to testimonies of eyewitnesses and neighbors of the targeted families to the legal center, we mentioned in this report the number of the killed and injured victims. The attacks resulted in the killing of 9 civilians, including 3 women and 4 children, injuring 2 civilians including a child and the complete destruction of targeted house which consists of two rooms and a kitchen.

### victims and witnesses' Testimonies:

Witness/ Ha'el Sa'id Handaj, 36 years old, a neighbor of the targeted family's home, told us the most prominent details of the crime, saying:

" At approximately 9:00 pm on Saturday, 10 February 2018, when I was at our house in Al-Sharja district, I was surprised to hear the first air raid, followed by the second one carried out by the Saudi Air Force.

I went out of the house to see the targeted place but the warplanes were still flying. We were afraid about of our lives from being targeted once again, so we stayed at our homes until the morning.

We, in the morning, rushed with many civilians to the targeted area and when arriving, we were surprised by a great tragedy scene. The attacks turned the house of Ahmed Mohammed Naharee to rubble, we found the remains of his killed family's members and of another family's members who were living with him in his house.

We found only three bodies whom we identified, they /Ahmed Naharee and his two children, while the rest of his family and a number of the family of Hamidi Handaj their bodies were torn into only pieces could not identify. The result was a terrible, the lives of an entire family and a number of the second family, including children and women, were assassinated by the warplanes, two civilians were wounded, one of them a child and the entire house was destroyed.

There is no justification for all this criminal brutality of Saudi Arabia and its alliance by bombing these innocent civilian families".

## Witness / Mohammed Mohammed Ali Jaramuz, 55 years old, the wise man in the area, said:

"I woke up in panic to the sound of the two airstrikes, and after the raids, I tried to get out of my house to see the site of the bombing but the warplanes were still flying on the area.

We stayed at our house and the next morning I sent my son to see the targeted place. He told me - after he went to the targeted place - that the warplanes targeted the home of one of the people of the area named Ahmad Naharee and killing all members of his family and another family. After hearing the words from my son, I ran towards the targeted place, the brutal bombs attacked them as they were sleeping peacefully in their home.

I, along with my son and others from the surrounding area, collected the flesh and remains of the killed victims and put them in blankets. We called the security office to come and take the bodies and the remains of the victims.

The victims who were killed by the bombing of the Saudi airstrikes, were innocent civilians, most of whom were women and children and have no guilty, and there are no camps or weapons stores in the region".

## Witness / Mohsen Mohammed Jarmoz, 45 years old, one of the people of the region of Al-Shraja, reported us saying:

"The barbaric raids on the home of a resident of Al-Sharja village of on Saturday night, but due to the lack of light and the fear of residents of the region of the double target of war against the rescuers and paramedics, we stayed in our places until the next morning.

Among the victims were two wounded, including a 15-year-old boy who was bleeding and crying all night to save them. We took all the wounded to the hospital

The two raids killed Ahmed Mohammed Naharee's and his entire family, consisting of , his wife and four children, as well as three civilians from the Hamidi Handaj family. The residents of the coastal area suffered from food shortage due to siege imposed by Saudi Arabia and the countries of the alliance aggression on Yemen and the destruction of sources of income by the Saudi warplanes attacking. The people of the region live on fishing to provide the demands of their families and children.

Everything has become devastating, people are suffering and their suffering is compounded by the spread of diseases and epidemics due to lack of electricity, infrastructure and sanitation. Life here has become very difficult".


## **Official Statement:**

During the communication of the Monitoring and Documentation Team at the Legal Center for Rights and Development with the Security Department in the region to document the aerial bombing incident of the Saudi Aggression Alliance on the house of Ahmad Naharee, one of the staff reported that the security office AlJarahe directorate received an appeal from the people of Al-Sharja area to come and take the bodies of the killed victims of the Saudi warplanes on Saturday night, February 10, 2018.

The raids resulted in the destruction of two houses belonging to Ahmed Muhammad Naharee. The security office has conducted field visits to the targeted location, taking the bodies of the victims and archiving the reports and complaints according to its jurisdiction. The location of the raids is a civilian house and the area has no camps or weapons stores.

Description of the violation according to the international humanitarian law:

It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

## **Center Recommendations:**

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
