Abstract:

The air force continues to target civilians' houses and properties. Even the tents of the nomads and their cattle were not immune from the raids of the brutal aggression, which affected everything from the beginning of the aggression until the day that the aircraft targeted two tents of the citizen, Abdullah Dhari in which killed the women, children and eliminated the cattle in Al-Abla Area - Harf Sufian Directorate - Amran Governorate before dawn time on Friday, May 26, 2018.

Incident Details

The children and women were inside the tent and the father was next to it. At 2 am before dawn time on Friday, the coalition of aggression flew in the sky of Sufian Directorate in Amran governorate launching two raids targeting the tent that inhabited by the wife of the martyr mother of his children. She was with her children at her father's house after the death of her husband.

But the flight of the Aggression launched two brutal raids targeting and killing the mother of orphans alongside with one of her children and wounding the third child seriously. Furthermore, burning the tent and all the furniture and all contents as well as burning a car and causing the death of a number of cattle in a crime against humanity added to the series of crimes committed by coalition aircraft since the beginning of the aggression on Yemen.

victims and witnesses' Testimonies:

li Ahsen kursan, a 55-year-old relative of the victims, who was met and said:

" It was 2 am before dawn time on Friday while we were asleep. We heard the sound of the raid. After that, we heard two loud explosions which were carried out by two air raids on the tent and the car. The son of the martyr and his mother were sleeping in the tent. My son and I, after we heard that, rushed to the place of bombardment to rescue if possible. Unfortunately, the fire has already burned my grandson and his mother, the tent and the car beside. A number of sheep were killed by the two raids which destroyed everything."

Abdullah Saleh Ali Dhawi, 40 years old was contacted and said:

"I was asleep next to the tent where my daughter and her children were. It was two O'clock am before dawn time, the plane surprised us with two raids. The first raid targeted the tent and the second targeted the car as well as the sheep beside. Inside the tent was my daughter and her children while I was sleeping outside. Some dust and soil covered me but I was fine. My daughter is killed and her child whose father was killed two years ago because of the bombing. My second daughter, a 10-year-old girl, was seriously injured and taken to hospital. "Why are we being targeted by the warplanes? We are civilians, we have done no fault, and there is nothing to justify bombing us," he said."




Ali Muqbel Hadi, a 35-year-old, is a resident of the area, said:

" At 2:00 am on Friday, the Air Force launched an air strike targeting the family of Abdullah Ali in the second area, Sufian which resulted in the killing of a mother and her child whose father was killed by a previous air strike, wounding another girl, burning the tent, destroying all the

property of the citizen as well as his car, killing his sheep and damaging all furniture without any guilt committed by the targeted civilians."

Description of the violation according to the international humanitarian law:

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
