Abstract:

At midnight on Sunday, May 27, 2018, the warplanes of the Saudi alliance launched an air strike targeting the car maintenance and repair shop belonging to the mechanical engineer Adel Abdullah Amr Kbsi located on the coastal main road in Al-Nakhilah Area – Al-Duraihmi - Hodeidah Governorate which is overlooking the Red Sea. The brutal raid resulted in the death of (2) civilians, one of them is a worker in the workshop. The owner of the workshop was severely injured, and caused heavy damage to his targeted workshop and two civilian vehicles, one of which was passing by the main road at the moment of bombing. The bombing also, destroyed two motorcycles owned by the victims and damaged the main road.

Incident Details

A military aircraft of the Saudi Aggression Coalition fired a missile at 12:00 pm on Sunday, May 27, 2018, on a workshop for the repair and maintenance of civilian vehicles located on the coastal main road in Al-Nakhilah Area – Al-Duraihmi - Hodeidah Governorate. (2) Civilians were killed and injured another one who is the owner of the workshop. legal center for rights and development has got the names of the killed and injured victims. They were Sami Maqbool Shridi, a 27-year-old workshop worker, and Ibrahim Ayesh, a traveler, both victims were killed while Adel Abdullah Kbsi, 28-year-old and the owner of the workshop was injured. The bombing, destroyed two motorcycles owned by the victims, the workshop of Adel Abdullah Kbsi and damaged the main road.




victims and witnesses' Testimonies:

Adel Abdullah Kbsi, 28 years, is the owner of the targeted car maintenance workshop, he was injured by shrapnel throughout his body. We met him at the hospital and told us the incident details saying:

" I have a workshop for maintenance and repair of cars and commercial tankers in Al- Nakhilah Area, on the coastal road, it was the only source of income for me and my family. Due to the miserable situation that the people of Hodeidah and Yemen suffer from in general as a result of the aggression and the siege imposed by the coalition of Saudi aggression on Yemen and its destruction of sources of income and business, I have employed many workers in my workshop. The work in spite of the hostile circumstances of the Saudi alliance and its brutal attacks on the directorates of the coast in Hodeidah is going well. At twelve o'clock of Sunday night, while I and one of the workers / Sami Maqbool Shridi were doing our work in the workshop and repairing a car for one of our customers, we were surprised by the air raid on the workshop that threw us outside workshop for several meters. I lost my consciousness for about half an hour then, I woke up and found my body heavily injured and was bleeding. I was asking for help, I could not find anyone to save me, I saw my friend and another traveler were scattered on the main road, I was calling them to make sure about them but they did not answer me, the shrapnel torn their bodies. I stayed on the main road, I was suffering the pain of the injury, I was afraid that someone would not hear me and come to help me. I stayed until 2 am of the next day and after that, a passenger stopped his car and took me to the hospital. As you see, I still receive medical care at this hospital. My simple workshop was not a military target, it is a civilian workshop, I do not know why this brutality against us?

Description of the violation according to the international humanitarian law:

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
