Incident Details

At 8 am on Tuesday, May 29, 2018, the warplane of the Saudi alliance launched two air raids targeting two trucks full goods as they passed through the main road in Shaneen Al Quba area - Directorate of Al-Makhder - Ibb. The trucks were destined to unload their cargo of aluminum and other materials to stores of Sanad Trading. The two trucks belong to Hamoud Ahmed Da'er. The two air raids resulted in the death of a driver of one of the two trucks and the injury of the other driver and a child accompanying them. In addition, 5 civilians from the Shaneen Al Quba area were injured seriously. (5) civilian houses, the mosque of the area, and the main road, as well as a large number of houses were damaged and destroyed.

victims and witnesses' Testimonies:

Mua'ammr Hamoud Ahmed Da'er, 34 years old, is a relative of the targeted trucks' drivers whom we met, he told us the incident details sayig :




" We have two trucks, we rent them for some traders who use them in carrying goods from such ports as Al-A'abr land port in Marib where my brother Abdul Majid went there this time with some of our relatives and my son Osama Mua'ammr. They went to there on trucks three days ago to bring goods of a trader from Ibb governorate. As they were about to reach Ibb city to unload the cargo, specifically during their passage through the main road, the Saudi aggression launched two air raids on the two trucks and their drivers. My 24-year-old brother, Abdul Majid Hamoud was killed, while my relative, Abdul Majid Saleh Omran, aging 30 years, and my son Osama Mua'ammr were injured. The attacks destroyed their cargo of commercial goods and the two trucks."

Mustafa Ahmed al-Amri, 35, is an eyewitness, we met with him and he told us saying:






" I was sleeping but the two air raids of Saudi warplanes awakened me from my dream, I got panicked. After the sound of the first air raid, I got out of my home to see where exactly the bombing, I saw a large truck carrying commercial goods was destroyed by the raid and there was another truck about 100 meters away. I heard the scream of a child and the driver of the second truck asking for help, I rushed to them and saved them and took them to my house. At that moment the second raid targeted the second truck Causing the outbreak of large fire in the truck, we tried to extinguish the fire but we have not succeed in our attempt to extinguish the it. After the raids, we got out to recover the body of the driver of the first truck who was killed by the raid, we found only the lower part of his body. The attacks destroyed the two trucks and its goods completely, about 6 civilians were injured and one was killed. The attacks also destroyed 5 houses and a mosque."

Description of the violation according to the international humanitarian law:

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
