Incident Details

At 6 pm on Friday, 1 June 2018, the Saudi aggression coalition launched missile bombardment on the houses of civilians in Bani Saad area of Al-Daher Directorate in Sa'ada governorate, one of the rockets hit the house of / Mansour Hussein Hammam and partially destroyed it. The targeting caused in the injury of the house owner, he got second-degree burns while his seven-year-old daughter, Kifah Mansour, was wounded by two shrapnel. The rest of his family, his wife and two of his children, were miraculously survived, they were grazing their sheep.

According to eyewitnesses who reported the Legal Center for Rights and Development, they said that their densely populated area, homes and properties have been bombed by rockets and heavy artillery shells which some of them carry cluster bombs since the beginning of the Saudi aggression and its alliance on Yemen. The house of Mansour Hammam had already targeted by a number of rockets and artillery shells reached to 13 rockets and artillery shells Launched by the Saudi coalition forces on the area at noon on Saturday.

victims and witnesses' Testimonies:

Yahya Ahmad Ali al-Sa'di, 30 years old, is an, we met him and he said:

"I was in my house waiting for Al-Maghreb pray to breakfast (it is Ramadan) and at six in the evening I heard the sound of a missile targeted the area, I went out of my house to see where the rocket, I saw the smoke and dust rising from the house of our neighbor Mansour Hammam and heard his appeal to extinguish the fire that broke out in his body after

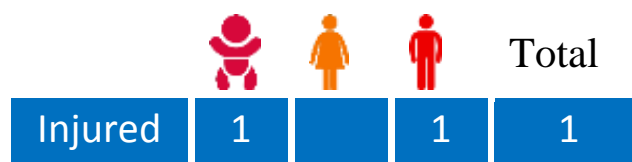
the missile targeted his house. When I saw him, I rushed to him and helped him and stopped the fire that covered his body, I and another person took him to a place under a tree and then took him on our shoulders to the main road where we paid 25 thousand riyals for a car to transport him to the Republican Hospital, the only hospital in the province, which has a special department deals with burns. Mansour Hammam got second-degree burns.”

Ali Abdullah Ali Najea’, aging 26, is an eyewitness told us the details of the incident saying:

“The area of Bani Saad is subjected to hysterical shelling with heavy artillery and missiles by the Saudi alliance in addition to the airstrikes carried out by the Saudi warplanes on the region for more than three years since the aggression on Yemen in which many civilians were killed mostly children and women as a result of those acts. On Saturday, the Saudi forces launched a rocket attack on the area of Bani area, one of these missiles targeted the house of Mansour Hussein Hammam and partially destroyed it. The owner of the house and his child were seriously injured and burned. I and some civilians went to transport the injured people to the hospital where they received medical treatment.

Description of the violation according to the international humanitarian law:

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
