Incident Details

At 3 pm on Monday, June 11, a Saudi warplane fired a deadly missile targeted the transit port of Kamran Island, located on the coast of AlSalif district on the Red Sea in Hodeidah province, killing a 30-year-old civilian called Ghali Qasim Musawa and injuring 4 others. The injured civilians are the child/ Mahmoud Ahmed Sami Jrad, Mohammed Hassan Hassan Aman, Abdullah Mohammed Zareba and Mohammed Shrah and they were taken to hospital in the city of Hodeidah.

The air raid destroyed the port partially, and destroyed two civilian cars and four bicycles. This port is the lifeline and the only outlet for the residents of Kamran Island.

victims and witnesses' Testimonies:

Suleiman Abdullah Bilghaith, 25 years old, is an eyewitness and a survivor of the air raid on the port, we met him during his presence at Al Thawra Hospital in Hodeidah next to the wounded child, Mahmoud Ahmed Jrad, who is under medical supervision. The witness reported us saying:

"I was in the port facilitating the passaging of civilians who come from or to Kamran Island. At 2:30 pm as we heard the warplanes flying which continued until 3 pm, after that I was surprised to hear the sound of the air raid on us directly, I called for everyone to rush to the sea and when we got there, we heard the sound of the rocket explosion that targeted the port directly and saw the dust and smoke rising heavily in the targeted area.



One person was killed and four others were injured, including a child named Mahmoud Jrad, who was wounded with shrapnel in the left hand, I took him to the hospital.

The targeted port is the only lifeline for the people of Kamran Island, the main line connects the island with the province of Hodeidah.

Abdo Abker Mohammed Tarmabi, aging 45, is a resident from Kamran island whose son Ghali was killed by the air raid that targeted the port:

"We, the residents of Kamran island, have no land road leads out of our Island except this port which has been targeted by the Saudi warplanes. At 3:00 pm on Monday, June 11, 2016, the Saudi warplanes launched an airstrike on the port resulted in the killing of my cousin / Ghali Qasim Musawa 30-year-old, he has a car carrying passengers, this car was the only source of income for him. The brutal raid injured 4 civilians, including a child."

Incident Results:

Civilian Victims: Total Killed 1 Injured **Civil Facilities:** Destroyed





Description of the violation according to the international manitarian law:

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
